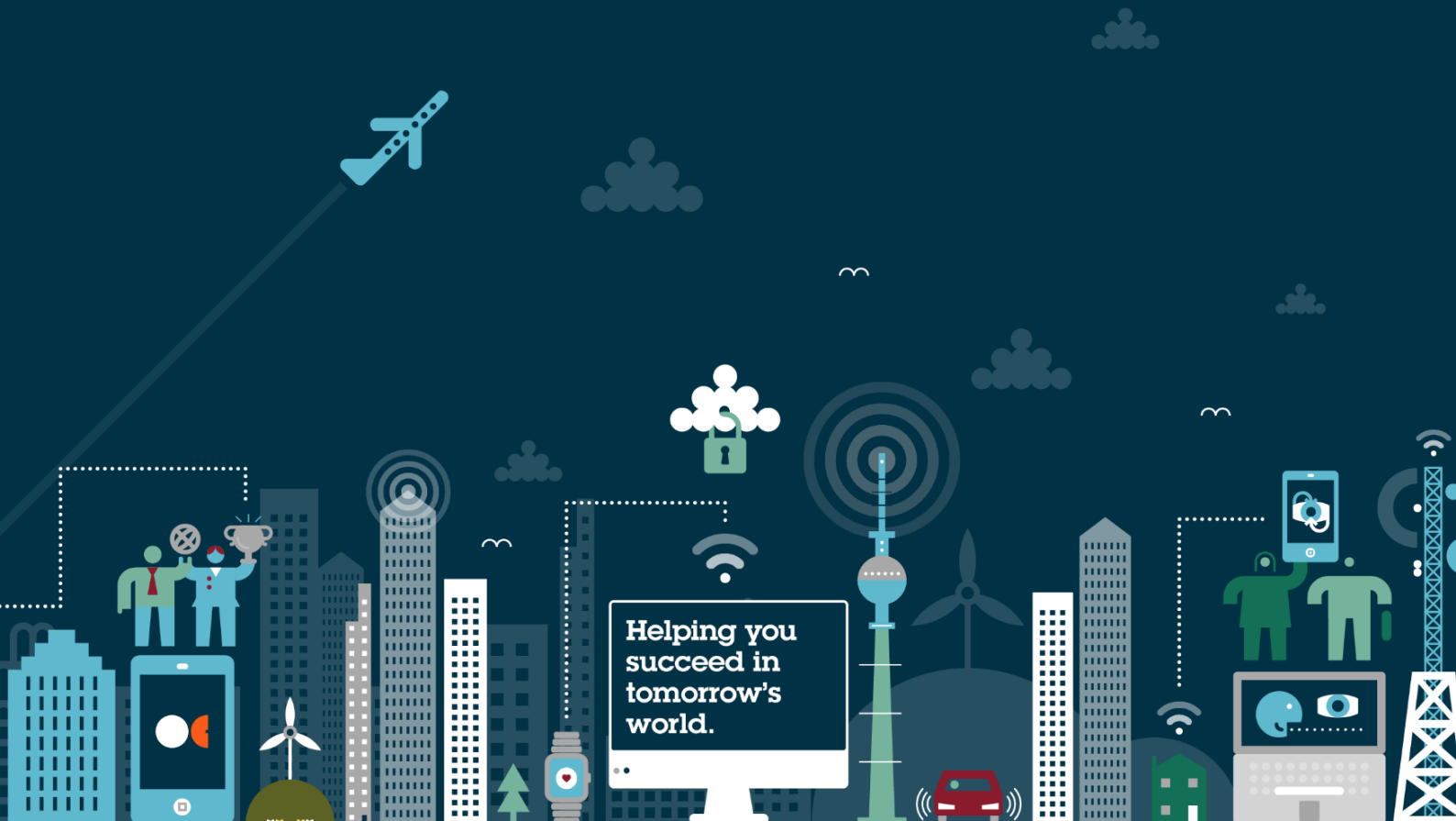

Our numbers

We chose 2019 as the reference year because it is representative of the firm's normal business. The years 2020 and 2021, subject to major operational anomalies as a result of the Covid-19 pandemic, were regularly reported but cannot be considered as indicative for the purposes of the analysis.

Emissions analysis

Owing to the nature of the sector in which the firm operates and as a result of the various initiatives it has already undertaken, the firm records very limited direct emissions (Scope I) with more significant indirect emissions from energy consumption (Scope II), while other indirect emissions (Scope III) - particularly those arising from commuting, followed by business travel - constitute the most important factor.
